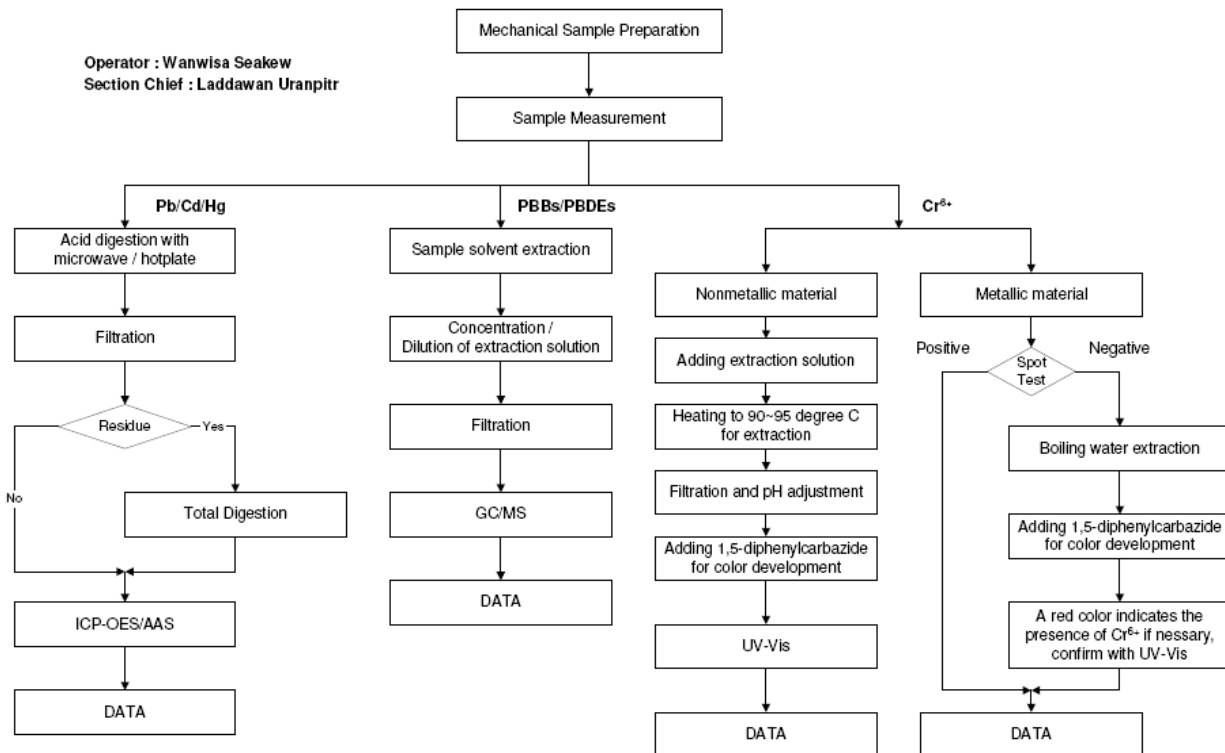

Flow Chart for RoHS : Pb/Cd/Hg/Cr⁶⁺/PBBs/PBDEs Testing



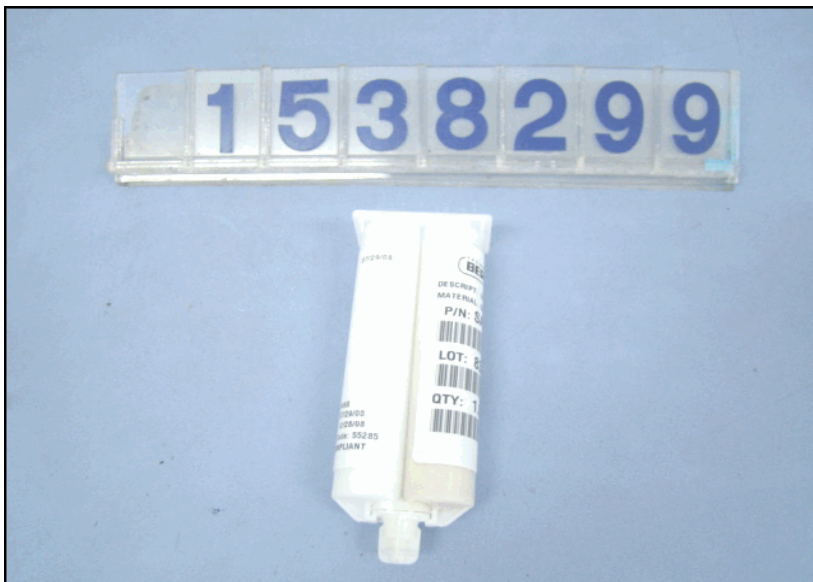
